- Abstract: This collection contains one volume (74 photoprints) and three folders documenting twelve built works by the architectural firm of Tilden, Register & Pepper and its predecessor firm Tilden & Register. In addition, the collection contains two folders of biographical materials related to the life and career of Marmaduke Tilden, Jr.

Biographical/Historical Sketch

Marmaduke Tilden, Jr. (1883-1957) and H. Bartol Register (1886-1956) established the firm Tilden & Register in 1916. In 1925 George Wharton Pepper, Jr. (1895-1949) joined the partnership, forming the firm of Tilden, Register & Pepper. The firm continued to practice until Pepper withdrew to form his own office in 1936.

Scope and Content Note

This collection contains 74 photoprints and three folders of miscellaneous items documenting twelve built works by the architectural firm of Tilden, Register & Pepper and its predecessor firm Tilden & Register. In addition, the collection contains two folders of biographical materials related to the life and career of Marmaduke Tilden, Jr.

A volume of 74 project photographs, ca. 1919-1930, documents many of the firm's major domestic commissions in the Philadelphia region, as well as summer houses in Isleboro, Rockport, and Northeast Harbor, Maine. Houses for Schofield Andrews, Donald D. Dodge, Joseph J. Greenberg, and George Wharton Pepper are particularly well documented. Also documented is the firm's institutional work for the Huntingdon Valley Country Club and the University of Pennsylvania Hospital's Maloney Pavilion. 28 photoprints bear the mark of Samuel H. Gottscho, photographer. This volume was annotated by an unknown person ca. 1950 with names of projects and locations. It should also be noted that names in the annotations may not be those of the original client. For the purposes of organization, the names of the original clients are used in this finding aid. Names of later owners, identified from the annotations, are included as other names.

The collection includes a small amount of biographical material related to Marmaduke Tilden, Jr., through whose family the material came into the Architectural Archives collection. Holdings include: a biographical note (author and date unknown) about Tilden's life and career, including mention of his longtime friendship with Franklin Delano Roosevelt; a photographic portrait of Tilden, ca. 1905; and a small amount of correspondence dated 1925 and 1959 related to the Dodge Residence.

The collection includes no office files or architectural drawings. Nor is there any documentation of the following important projects: U.S. Post Office, Philadelphia; 1616 Walnut Street Building, Philadelphia; or Tilden's work as supervising architect of the Pentagon.

The collection is arranged in two series:

- I. Photographic portfolio of the work of Tilden, Register and Pepper, ca. 1925-1930.
- II. Photographs and Miscellany, 1905-1959.
